Besetzung

Für die Inszenierung werden vier Personen benötigt.

1. Person: Wahr
2. Person: Falsch
3. Person: CPU
4. Person: Display

Material

Alle Akteure tragen weiße Arbeitskittel, an deren linker Brusttasche Namensschilder mit folgenden Bezeichnungen angebracht sind: Wahr, Falsch, CPU und Display.

Weitere Ausstattung: Drei neutrale Tische und Stühle für Wahr, Falsch und CPU. Auf den beiden Tischen von Wahr und Falsch liegen die jeweiligen Skripte und jeweils ein Stift zum Abstreichen der gelesenen Zeichen.

Auf dem Tisch von CPU liegt ein Stift und weißes Papier, die Ascii-Zuordnungstabelle, eine Schere und Buchstabenbögen.

Display klebt die Buchstaben sorgfältig auf die Wandpanele.

Die Wandpanele sind 100 cm breit und 140 cm hoch.

Alle Listen und Tabellen müssen in der angegebenen Menge ausgedruckt werden.

Die beigelegten Skripte und Buchstabenlisten reichen für ca. eine Stunde Performance.

Aufgrund der großen Datenmenge gibt es die kompletten Listen auf Nachfrage als PDF.

Ablauf

Anhand der beiliegenden Listen lesen Wahr und Falsch abwechselnd Nullen und Einsen vor.

Dabei liest Wahr nur die Einsen vor und Falsch die Nullen. Immer acht Nullen und Einsen werden zu einem Buchstaben zusammengefasst: Die Folge „01000001“ bezeichnet zum Beispiel den Buchstaben „A“.

Die Listen sind wie folgt strukturiert:

Jede Liste besteht aus mehreren Blöcken mit acht Spalten.

Die linke Tabelle zeigt einen Ausschnitt aus der Liste mit Nullen

Die rechte Tabelle zeigt einen Ausschnitt aus der Liste mit Einsen

In diesem Beispiel beginnt Falsch mit der Null, darauf liest Wahr eine Eins vor und Falsch fünf mal die Null. Wahr beendet den Achterblock mit der Eins. Nach jeweils acht Nullen und Einsen machen Wahr und Falsch eine Pause bis CPU den Buchstaben interpretiert und Display ihn angeklebt hat.

CPU schreibt den Vortrag von Wahr und Falsch mit, interpretiert ihn mittels der ASCII-Zuordnungstabelle, schneidet den korrespondierenden Buchstaben aus Papier aus und übergibt ihn an Display, den vierten Akteur.

Display übernimmt den ausgeschnittenen Buchstaben von CPU und klebt ihn an die Wand.

Wahr und Falsch beginnen mit dem nächsten Null-Eins-Block.

Anmerkungen

Fehler, die im Prozess entstehen, wenn etwa Wahr oder Falsch sich beim Vorlesen vertun oder CPU den Code falsch interpretiert, dürfen nicht korrigiert werden.

Die Geschwindigkeit, in der die Akteure arbeiten, bleibt ihnen selbst überlassen. Sie können zwischendrin auch aufstehen und auf Toilette gehen oder ähnliches. Das heißt allerdings, dass die anderen warten müssen, bis der fehlende Akteur zurück ist.

Die Akteure dürfen während ihrer Arbeit nicht miteinander sprechen.

Preamble
